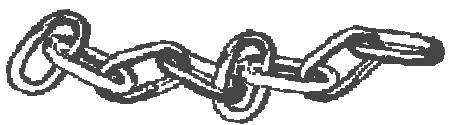

The Wilson Community Council is a community organization comprised of representatives from human service agencies and organizations throughout Wilson County.

PURPOSE

The Council, developed in 1969, offers a means for more coordination among health, welfare, rehabilitation, and other agencies.

OFFICERS

The Council is comprised of a president, past-president, vice president, and secretary/treasurer, elected annually.

MEMBERSHIP

Any full or part-time professional, or staff member in good standing of any organizations in Wilson County that provide services to the city or county is eligible to join.

DUES

Dues are \$15.00 per year for each member organization paid to the Council's secretary/treasurer.

SPEAKER

The vice president recruits and selects an informative speaker for each meeting. Suggestions may be made from the floor for further topics of interest.

MEETINGS

Meetings shall be held at a place designated by the president or a vote of the membership. Meetings are held the second Monday in each month at 12:00 noon. Each meeting lasts approximately one hour. Each member is responsible for his/her meal and his/her guest. The speaker's meal is paid for out of the treasury of the Council, unless he/she is already a paid member of the Council.

Agencies will be notified as a reminder by phone/mail/fax/email of each meeting.

At each meeting, time will be allotted for special announcements from agencies, and distribution of any related flyers or brochures.
